**PUBLIC COMMENT:**

**Barb Varner, 5 Maple Drive** Ms. Varner voiced her concerns with the current Burning Ordinance. She questioned how the Township could receive a grant when they have recycling in place and allow open burning.

**DISCUSSION ITEMS:**

1. Discussion ensued with regard to changing the Burning Ordinance. Chairman Toothaker directed Supervisors Miller and Cantrell to work with the Solicitor in drafting revisions to the current Ordinance.
2. Discussion ensued with regard to changing the Zoning Ordinance to allow smaller lot sizes for chickens. Chairman Toothaker will work with the solicitor to revise the ordinance.
3. Discussion ensued with regard to the Township taking over the Newberry Township Municipal Authority. Chairman Toothaker volunteered to fill the vacancy on the Authority's Board. He also stated that the Authority's Solicitor, Dan Altland, contacted him about other options to keep the Authority separate. He also said that the township solicitor had been approached by PA American Water with an interest in the sewer system.
4. Vice-Chairman Kauffman stated that a Candidates' Debate was being held at the Fairview Township Fire Station on April 19 at 6:30 P.M.
