# BOARD OF SUPERVISORS MINUTES May 24, 2016

#### CALL TO ORDER

The Newberry Township Board of Supervisors held their regular meeting at the Township Municipal Building, 1915 Old Trail Road, Etters, PA. The meeting was called to order by Chairman William Toothaker at 6:00 P.M.. Chairman Toothaker proceeded with the pledge to the flag. Present at the meeting were, Vice-Chair Maxine Kauffman, Supervisor Brandt Cook, Supervisor David Cantrell and Supervisor Anthony Miller. Also present, Manager Don Keener, Chief John Snyder, Codes & Zoning Officer Jeff Martz, Engineer Bill Rudy and Solicitor Margaret Driscoll.

#### **PUBLIC COMMENT**

**Bob Eyer, 90 Southcrest** Mr. Eyer prayed for the community and first responders.

**Red Land Little League** Scott Sozanski presented a rendering of the proposed ball fields, pavilions, walking path and concession stand for Lexington Estates Park.

**Goodman Logistics** Mr. Kobularcik presented various options to provide sanitary sewer at the warehouse they propose to build on Yorktown Road. The Board directed Bill to meet with Brent Zeiders to review the options and bring a recommendation to the Board by their meeting on June 28.

**Sherilyn Kanyuck, 925 Pleasant Drive** Mrs. Kanyuck commented that her trash had not been picked up at the property they were demolishing. Don stated that the hauler had been contacted and it was to be picked up.

**Tony Martone, 35 Brook Circle** Mr. Martone indicated that whoever plowed the snow the last two winters on his road pushes snow directly into his driveway while he's away in Florida. Chairman Toothaker directed Don to look into this and have it taken care of. Mr. Martone commented that the vacant home at the corner of York Haven and Valley Green Roads needs the doors secured to keep children from going into it. The Board directed Jeff to take care of it.

He presented proposals from Fairview Township EMS and Community Fire and Health Services for Basic and Advanced Life Support Services to the Township. Newberry Township Fire Department will hold a boot drive on Newberry Parkway on May 29.

**Zoning:** Jeff provided a written report and indicated that he would like some direction from the Board on how to deal with blighted properties. Ms. Driscoll indicated that she would work with Jeff with regard to the properties.

**Solicitor:** Ms. Driscoll provided a written report. Discussion ensued with regard to residents keeping chickens.

**Engineer:** Bill provided a written report. Bill stated that the Act 537 Plan was ready for the Board to act on. It will need to be advertised, then adopted by the Board and then go to the Department of Environmental Protection for review.

**Public Works Director** Chairman Toothaker indicated that the Board was to interview the applicants at the Executive Session.
