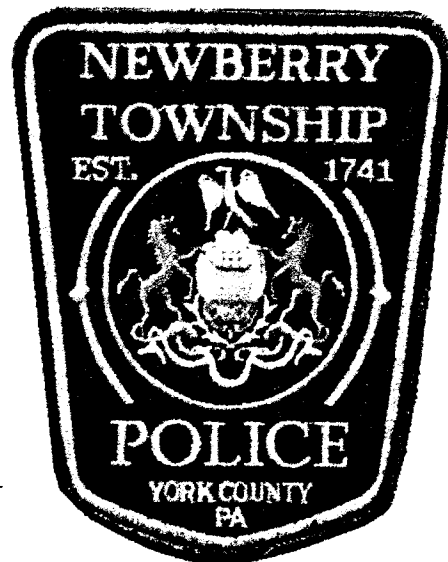

Supervisors and Staff,

The department handled 936 calls for the month of April 2019. Listing the calls by criteria, 1 Rape, 1 Aggregated Assault, 2 Burglaries, 20 Thefts, 2 Motor Vehicle Theft, 13 drug offenses, 17 DUI's, 3 Simple Assaults, 7 Sexual Assaults, 3 Domestic related harassments, 3 other harassments, and 25 all other offenses. Additionally, officers responded to and investigated 839 other calls for service including 19 domestic related incidents and 26 traffic accidents. They issued 177 traffic citations, 214 traffic warnings, issued 11 non-traffic citations, and made 43 misdemeanor/ felony criminal arrests.
