BOARD OF SUPERVISORS MINUTES October 24, 2017

CALL TO ORDER

The Newberry Township Board of Supervisors held their regular meeting at the Township Municipal Building, 1915 Old Trail Road, Etters, PA. The meeting was called to order by Chairman William Toothaker at 6:22 P.M. Chairman Toothaker proceeded with the pledge to the flag. Present at the meeting were: Vice-Chairman Anthony Miller, Supervisor Brandt Cook, Supervisor Maxine Kauffman and Supervisor David Cantrell. Also present, Manager Don Keener, Chief John Snyder, Codes & Zoning Officer Jeff Martz, Public Works Director Scott Getgen, Wastewater Coordinator Brent Zeiders, Engineer Bill Rudy and Solicitor Andrew Miller.

Chairman Toothaker announced that prior to the meeting the Board had an Executive Session to discuss contract negotiations.

The Board directed Chief Snyder to place the Speed Board and have the police due more enforcement on River Road. Mr. Haugh was directed to meet with Jeff to discuss the non-conforming use and expansion of Save Rite.

Doug Ross, Red Land Community Library Mr. Ross discussed the various programs coming up for the Library. He commented that they were thankful for the over forty volunteers helping with the library.

Mark Keener, Lewisberry Borough Council Mr. Keener commented that the Borough appreciated the great service they received from the Police Department but they were concerned with the cost going up. He also indicated they'd like to get a two year proposal for any cost increases.

correct their non-compliance stated in the Auditor General's Audit. Vote on Motion. 5 Ayes. Motion carried.

Authorize Execution of the Clover Crossing EDU Transfer Agreement Motion made by Supervisor Cook, seconded by Vice-Chairman Miller, to authorize the Execution of the Agreement. Vote on Motion. 5 Ayes. Motion carried

Discussion of the 2018 Budget The Board agreed, by consensus, to increase the amount given to the Senior Centers to \$21,000.00 (\$17,000 to Red Land and \$4,000 to Northeastern) for the 2018 Budget.

Meeting Date Change Motion made by Supervisor Cantrell, seconded by Supervisor Kauffman, to cancel the Board of Supervisors Meeting on November 28th and move it to November 14th at 6:00pm . Vote on Motion. 5 Ayes. Motion carried
