**Call to Order by Vice Chairman Kauffman**

Vice Chairman Kauffman called the 2021 Budget Workshop to order at 6:00 p.m.

**Old Business**

Review of the revised draft budget was held. Discussion was held on any areas that were changed based on the prior meeting. Additional changes were requested by the Board on the revised draft budget.

### **New Business**

MOTION by Supervisor Cook to advertise the amended budget. The motion, seconded by Supervisor Eckert, carried unanimously.

A maximum of one person at time could address the board, while others would wait in their cars. A list would be followed and each person would be called into the meeting. Once that person has spoken, they would then have to leave the building before the next person comes in to address the Board.

MOTION by Supervisor Eckert to open the meetings up to allow our residents to come in one at a time to address the board. The motion, seconded by Supervisor Wintermyer, carried unanimously.

MOTION by Supervisor Cook to approve the Solicitor and Engineer to represent the Township at the November 23, 2020 Zoning Board Hearing. The motion, seconded by Supervisor Eckert, carried unanimously.

MOTION by Supervisor Cook to accept the resignation of Darnell Musser effective October 30, 2020. The motion, seconded by Supervisor Wintermyer, carried unanimously.

MOTION by Supervisor Eckert to approve the hiring to fill the Office Assistant vacancy at \$19.00 per hour. The motion, seconded by Supervisor Cook, carried unanimously.

Motion by Supervisor Cook to approve the payment of bills (67819-67840, 67841,1105, 12602-126120). The motion, seconded by Supervisor Wintermyer, carried unanimously.
