

NOTICE TO BID

Sealed bids will be received by the Newberry Township (“Township”) at 1915 Old Trail Road, Etners, Pennsylvania 17319 until 10:00 A.M on Monday, March 23, 2020, for the following items:

MINI-PAVER WITH RETRACTABLE SCREED ATTACHMENT:

- The direction of paving with the unit is forward.
- Capable of paving up to 82 feet per minute.
- Mounts to any skid steer, compact track loader, or wheel loader (hereinafter “skid-steer” or “SS”) with:
 - A minimum operating/lift capacity of 1,600 pounds; and
 - A minimum hydraulic gpm low-flow of 16 gpm to front ports; and
 - An SSL Quick-Attach system or equivalent.
- Minimum hopper capacity of 49 cubic feet per 3.7 tons of asphalt.
- All hydraulically-driven functions include the auger, screed, and hopper top.
- All control functions shall be controlled via both a wired on-board control panel in the skid-steer and a hand-held radio remote control.
- Central auger shall be designed to move paving material from the hopper to the screed.
- Retractable heated off-set screed capable to screed with:
 - Paving width range of at least 8.0 inches to 74.0 inches; and
 - Paving thickness range of at least 2.0 inches to 9.5 inches.
- Automatic material flow control for side-discharge auger.
- Automatic height/grad adjustment attachment.
- Auger extension with a minimum of 2 limiter gates.
- Capable of laying both hot and cold asphalt, sand, and crushed stone.
- Attachment shall have a label alerting the operator of “Low Flow Only” hydraulic system attachment.
- Mini-paver and screed attachment must be painted with anti-corrosive paint.
- One year parts and labor warranty on all equipment being provided under this bid, including without limitation, the mini-paver, retractable screed attachment, and any other accessory parts included therein.
- Hopper shall be of sufficient size and configuration to receive material directly from a dump truck into the hopper.
- Unit must include a propane tank holder (propane tank to be supplied by the Township).
- Manufacturer’s standard safety decals shall be displayed on the attachment.
- Successful bidder shall supply one mandatory factory-authorized equipment training to Township-designated personnel (not to exceed 15 hours).
- Hand-held wash-down pump for paver wash down.
- **OPTIONAL BID:** Secondary height/grade adjustment attachment.

Bids shall only be accepted by first class mail, certified or registered mail, or hand delivery received by the above deadline. The bids shall be opened at 11:00 A.M. on Monday, March 23, 2020, and will considered during the Board of Supervisors meeting on Tuesday, March 24, 2020, at 6:00 p.m.

Bid packets are available at the Township office. Bids must be submitted on the form provided as part of the bid packet. Bids are irrevocable for a period of sixty (60) days after the bid opening. The Board of Supervisors reserves the right to waive any formalities or nonmaterial defects in its sole discretion, and to reject any and all bids.
